

#### **Online training**

All training sessions are held online via Zoom. Recordings of the training sessions will be made available to all trainees. If you are unable to attend scheduled training days, you can find the recordings and ask questions via the common notes of the training event.



#### **Training times**

Training sessions start at 2pm CEST / 8am EDT and end either at 5pm CEST / 11am EDT or at 6pm CEST / 12noon EDT. We realize this is early for the EDT time zone, and late for the CEST time zone. If you are not able to arrange availability for the full sessions, please do let us know.

Should your group be located in a different part of the world (e.g. Asia or the Western part of America), we will do our utmost to accommodate these time zones as well.

#### **Expected trainings in 2024**

Next to the Facilitator Training Module in Q2 of 2024, a Trainers Training Module will be scheduled in the 2nd half of 2024. Dates for these training sessions will follow shortly.

#### Minimal training capacity

Training Modules begin once 12 trainees or more have signed up. Independent groups can be combined to reach this minimal number of trainees. A course will have a maximum of ca. 25 trainees.
